Owner Agreement & Release Form

This agreement shall be in force from the date signed and for all visits thereafter to The Wag Factory LLC

I hereby certify that my dog(s) is/are in good health and has/have had no communicable diseases in the last 30 days. My dog(s) is/are current on all required vaccinations and a flea preventative. I further certify that my dog(s) has/have not harmed or shown aggressive or threatening behavior towards any person or other dog. I give authorization to The Wag Factory LLC, hereafter referred to as 'TWF', to speak with my veterinarian and/or their staff to confirm my dog(s) vaccination status and medical history.

I have read and understand the following:

1 I agree to pay the rate for services in effect on the date my dog(s) attend(s) TWF. Prices are subject to change at any time. No dog will be released until all charges are paid in full. Cancellation fees may be applied for reservations cancelled later than 5 pm the day prior to a scheduled reservation.

2 I understand that the hours of operation are from 7 am to 7 pm daily. I agree to pay the \$1/minute late fee for each dog picked up after 7 pm. Dogs not picked up by 7:30 pm will be subject to an additional boarding charge and released the next day, unless arrangements with TWF are made to the contrary.

3 Should I fail to contact TWF within 48 hours of scheduled pick-up, my dog(s) will be considered to be abandoned. Any expenses and fees incurred by TWF for services provided to said dog(s) during the abandonment period shall be paid by me. I hereby grant a lien on said dog(s) for any and all unpaid charges resulting from services provided by, at, or through TWF.

4 TWF reserves the right to refuse admittance to any dog(s) not meeting temperament and health requirements.

5 I understand that there are inherent risks of illness or injury when dealing with animals.

6 I agree to indemnify TWF, its owners, staff, and volunteers for any loss, liability, damage or costs they may incur due to my dog(s) participation while attending TWF.

7 TWF reserves the right to administer aid and/or use any available veterinarian to care for my dog(s) should the need arise, whether or not TWF can reach me or my emergency contact. I assume full financial responsibility for any and all veterinary expenses incurred, in addition to other fees incurred for services provided at or by TWF.

8 I understand that I am solely responsible for any harm or damage caused by my dog(s) while attending TWF. and agree to indemnify TWF, its owners, staff, and volunteers for any loss, liability, damage, or costs they may incur. I further agree that any problems that develop with my dog(s) will be treated as deemed best by TWF, in their sole discretion. and I assume full responsibility for any and all expenses involved.

9 I agree that this release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of South Carolina and if any portion thereof is held invalid, it is agreed the balance shall continue in full legal force and effect. Should any provision of this agreement be deemed unenforceable, TWF's liability shall be limited to the funds paid to it by me for taking care of my dog(s).

10 I agree that my dog(s) may be videotaped, photographed, and recorded. TWF shall retain the exclusive rights to the results and all proceeds of such, to copyright, to use and to license to others in any manner.
